POLICY

The Agency has established procedures designed both to protect the privacy of those who visit our Website and disclose the nature of the information the Agency gathers from these visitors. The Agency doesn't use its web presence to sell, rent, license or otherwise share personally identifiable information about Website visitors.

PROCEDURE

At UMFS, we are committed to implementing measures designed to protect the privacy of those using our services. The following discloses our information gathering and dissemination practices for this website.

INFORMATION COLLECTION AND USE

In general, you can visit UMFS' Website without telling us who you are or revealing any information about yourself. Our web servers collect the domain names, not the e-mail addresses, of visitors. This information is aggregated to measure the number of visits, average time spent on the site, pages viewed, etc. UMFS uses this information to improve the content of its Website. Also, there is a technology called cookies which can be used to provide you with tailored information from a website. UMFS does not use or collect information about you via cookies. If you wish to receive information from UMFS you may be required to give us your personal information such as your name, address, etc. We will only use this personal information to provide the service or information that you request or for which you register. We will not sell, rent, license, or otherwise share your personally identifiable information, including your e-mail address. UMFS may send mailings to you with information about new services or upcoming events.
